The Volunteer understands that the Activities may include Property cleanup, debris removal, distribution of emergency goods, and crisis counseling.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless Global Impact Ministries, Inc and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may hereafter arise from Volunteer's Activities with Global Impact Ministries, Inc.

VOLUNTEER UNDERSTANDS THAT THIS RELEASE DISCHARGES Global Impact Ministries, Inc FROM ANY LIABILITY OR CLAIM THAT THE VOLUNTEER MAY HAVE AGAINST Global Impact Ministries, Inc WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH Global Impact Ministries, Inc, WHETHER CAUSED BY THE NEGLIGENCE OF Global Impact Ministries, Inc OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS, OR OTHERWISE. VOLUNTEER ALSO UNDERSTANDS THAT Global Impact Ministries, Inc DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.

2. Medical Treatment. Volunteer does hereby release and forever discharge Global Impact Ministries, Inc from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Global Impact Ministries, Inc.

3. Assumption of the Risk. The Volunteer understands that the Activities may involve work that may be hazardous to the Volunteer, including, but not limited to, removal of debris, cutting and removal of downed trees, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities, and releases Global Impact Ministries, Inc from all liability from injury, illness, death, or property damage resulting from the Activities.

4. Insurance. The Volunteer understands that, except as otherwise agreed to by Global Impact Ministries, Inc in writing, Global Impact Ministries, Inc does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

5. Photographic Release. Volunteer does hereby grant and convey unto Global Impact Ministries, Inc all right, title, and interest in any and all photographic images and video or audio recordings made by Global Impact Ministries, Inc during the Volunteer's Activities with Global Impact Ministries, Inc, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State, and that this Release shall be governed by and interpreted in accordance with the laws of the State. Volunteer also agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

7. Indemnification. I further agree to defend, indemnify, and hold harmless the Released Parties from any and all claims, losses, injuries, and damages arising out of or in any way related to my participation in the missionary venture, including but not limited to claims by third parties and any claims submitted by me or on my behalf, even if arising from the negligence of the Released Parties, except that which is the result of gross negligence or wanton misconduct of the Released Parties.
